### What data do we collect?

Drift LARP collects the following data:

- Personal identification information (Name, email address, phone number, etc.)

## **How do we collect your data?**

You directly provide Drift LARP with most of the data we collect. We collect data and process data when you:

- Register online or place an order for any of our products or services.
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email.
- Use or view our website via your browser's cookies.

## **How will we use your data?**

Drift LARP collects your data so that we can:

- Process your order and manage your account.
- Email you with event updates and other important information.

Drift LARP does not share your information with any other entities (personal, commercial or otherwise).

## **How do we store your data?**

Drift LARP securely stores your data within an isolated Google Drive. This Google Drive is only accessible to a subset of the Game Team, necessary for event operation.

Drift LARP will keep your data for the duration of the operation of Drift LARP, or until deletion is requested.

## **Marketing**

Drift LARP would like to send you information about products and services of ours that we think you might like.

You have the right at any time to stop Drift LARP from contacting you for marketing purposes.

## **What are your data protection rights?**

Drift LARP would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

**The right to access** – You have the right to request Drift LARP for copies of your personal data. We may charge you a small fee for this service.

**The right to rectification** – You have the right to request that Drift LARP correct any information you believe is inaccurate. You also have the right to request Drift LARP to complete the information you believe is incomplete.

**The right to erasure** – You have the right to request that Drift LARP erase your personal data, under certain conditions.

**The right to restrict processing** – You have the right to request that Drift LARP restrict the processing of your personal data, under certain conditions.

**The right to object to processing** – You have the right to object to Drift LARP's processing of your personal data, under certain conditions.

**The right to data portability** – You have the right to request that Drift LARP transfer the data that we have collected to another organization, or directly to you, under certain conditions.

## **Cookies**

Cookies are text files placed on your computer to collect standard Internet log information and visitor behavior information. When you visit our websites, we may collect information from you automatically through cookies or similar technology

## **How do we use cookies?**

Drift LARP uses cookies in a range of ways to improve your experience on our website, including:

- Keeping you signed in
- Understanding how you use our website

## **What types of cookies do we use?**

There are a number of different types of cookies, however, our website uses:

- Functionality – Drift LARP uses these cookies so that we recognize you on our website and remember your previously selected preferences. These could include what language you prefer and location you are in. A mix of first-party and third-party cookies are used.
- Advertising – Drift LARP uses these cookies to collect information about your visit to our website, the content you viewed, the links you followed and information about your browser, device, and your IP address. Drift LARP sometimes shares some limited aspects of this data with third parties for advertising purposes. We may also share online data collected through cookies with our advertising partners. This means that when you visit another website, you may be shown advertising based on your browsing patterns on our website.

## **How to manage cookies**

You can set your browser not to accept cookies, and the above website tells you how to remove cookies from your browser. However, in a few cases, some of our website features may not function as a result.

## **Privacy policies of other websites**

The Drift LARP website contains links to other websites. Our privacy policy applies only to our website, so if you click on a link to another website, you should read their privacy policy.
